# REBUILD IOWA INFRASTRUCTURE FUND (RIIF)

HF2579 was introduced earlier this week and placed on the House agenda – additional Information can be found via the link below – some of the relative highlights follow:

#### **HIGHLIGHTS:**

- \$2.6 million for trails (Department of Transportation)
- \$1.5 million for water trails & low head dams (DNR)
- \$9.6 million for Lake Restoration (DNR)
- \$6 million for State Park Infrastructure (DNR)
- \$10 million for (CAT) Community Attraction & Tourism (Econ. Dev. Authority)
- \$2 million for Iowa Great Places (Cultural Affairs)
- \$12 million for Sports Tourism (Economic Development Authority)

#### IACCB BOARD OF DIRECTORS TO MEET MAY 12TH

The nine-member ICCS Board of Directors will hold their spring quarterly meeting on Thursday, May 12th in Des Moines. Each year, the May meeting is dedicated to review and approval of upcoming fiscal year budgets for both ICCS General Operations, and that of the MyCountyParks.com Website Operations. This year, the Board is also tasked with the following significant agenda items: Final Review and Approval of the new ICCS CEO Job Description; Review and Approval of the FY2023 CEO Compensation Contract; Review and Approval of the 2022 CEO Recruitment Plan; and, the Preliminary Review & Discussion of the MyCountyParks.com Internet Systems Administrator Position projected for onboarding around the beginning of 2023. If all goes well, letters of application will be solicited for the CEO position in late May/early June for a six week period.
