We need to grow and we can't wait for spring. One thing that surfaced immediately from this year's e-commerce summit was the urgent need for a credit card/digital payment system to be available through mycountyparks.com for all campsites, not just reservable campsites. Park Rangers and field staff have long imagined the day when they no longer had to constantly count through stacks of cash, checks, and pennies to verify registrations every day, or track down and inform campers that their envelope was somehow five dollars short. Admin staff would probably enjoy not having to do the recount and not worrying about chasing down hot checks! Finally, in today's world, we know that customers just want to use their card or phone app to register and pay as quickly and painlessly as possible. We must quickly adapt or risk loosing customers.

Thus the mycountyparks.com digital payment system is being developed as quickly as possible to provide customers and our counties with an adaptable easy-to-use payment system that will allow digital registration at all campsites. Yes, that includes first-come, first-serve sites! This system will work through a QR code and will allow users to register and pay for their site immediately through mycountyparks.com. The site will then notify staff through their calendar immediately, similar to the current reservation system.

There are some things to work through and figure out going forward. We must determine the best process, develop the functionality, and then deploy this feature. We have given this project top priority with the goal of making this available for the upcoming 2024 camping season! We ask for your patience as we work through this project, we promise to keep you informed as things progress. This is another critical evolution for our industry, and we believe it will help lead us to a more sustainable path of growth moving forward!

Do You Have A Need For Seed?



Join the Iowa DNR - CCB Prairie Seed Cooperative.

How does the Prairie Seed Coop work? Iowa DNR Prairie Resource Unit will provide materials to begin a plot for 1-5 species of prairie forbs, knowledge on how to get started, and seed cleaning for the project. The coop partner provides labor to plant, weed, and harvest the seed produced in the plot. In return for the input of sweat equity, the coop partner will receive a diverse seed mix in return. Plots can be small or large, managed with volunteers, seasonal staff or full-time employees, and species that are propagated can be selected from our list of species.

Iowa DNR Water Trails Grants Available

There are many state designated water trails and water trails under development that run through Iowa's 99 counties--see attached map. And, the CCBs are all eligible to apply for water trail enhancement grants for water accesses or other improvements, such as amenities at access sites, etc. The grant application provides further information about eligibility. We have a grant due on December 5 this year--\$500,000 is available statewide. In addition, we have an application for water trail planning. We

an application for water trail planning. We select one project per year from these applications via a scoring committee. The DNR Rivers Program funds all the planning pieces, but the project partners do need to be engaged in that process, but it comes absolutely free. The plan will lead to state designation. The process typically takes 18-24 months to complete. The pre-qualification section is due Dec 5th, as well. The final application is due in March 2024. Link Below


