# SPRING 2021 MANDATED TRAINING (SESSION DESCRIPTIONS FOR LINKS PROVIDED ON CCPOA WEBSITE)

Your **CCPOA Executive Committee** has assembled the following training topics, via online links, for your completion. They include what would have been provided at the 2020 Fall Workshop as well as what is new for 2020/21. The following meet all mandatory in-service hours recognized by ILEA for you to remain **CURRENT** for 2020!! These come at **No Cost** to you, with the exception of the new Implicit Bias/ De-Escalation training that was rolled out in the fall of 2020. (*see details below*)

**Domestic Abuse** (*Jen Swim, ILEA Instructor*)- This 54-minute video is being offered for the purpose of satisfying the annual 1 HR mandated training requirement for mental health. When connected to the provided link, you will simply just need to click on **Start Course** and then press the **Play** icon. There is no cost to you for this training.

**Hazardous Materials** (*Officer Chris Boswell, T265 Iowa DOT/ CCPOA*)- This two-part training meets the current OSHA Standard requirement our membership has been following. The first link features a 21-minute video currently being used at ILEA. It's simply a refresher on use of the Emergency Response Guidebook. The second link includes a short video & an interactive board game which provides a certificate upon completion. Allow 20 minutes for this & have your orange guidebook handy. There is no cost to you for this training.

**Mandatory Reporting & Dependent Care Abuse** (*Iowa Dept. of Human Services*)- This training remains **MANDATORY** and is now **only** available online through the provider. It consists of (2) 2-hour sessions covering both Child Abuse & Dependent Adult, for a total of 4 hrs. This aligns with our needed 4-hour requirement at this point in time. It will be followed by a one-hour refresher in the future. You must **first** access the **General Information** link to **sign in/create account** to access the needed training from the provider for both components. There is no cost to you for this training & a certificate will be generated upon completion.

**Implicit Bias/ De-Escalation- NEW-** (*ILEA & Thomas Newkirk, civil rights attorney*)- This requirement is **NEW** as of October 2020 following recent legislation. You will be required to register with ILEA for this 4-hour session administered via live stream. Future course dates & availability are listed on their website. There will be limited seating for each course & includes a **cost of \$50.00 per student**.

**Firearms Re-Certification-** (*on your own*)- This is an annual requirement. A "range day" had previously been offered last fall in two host counties with limited attendance. Please contact your CCPOA Executive Committee if you are having difficulty in finding this opportunity...

**I.L.E.E.C.P. Training- Trauma/ Medical Emergencies** (*Tim Neal, former Dept of Homeland Security*)- This is the final required component for your mandatory in-service training hours. We are currently working with Tim on a recorded presentation that will fulfill this requirement. This is scheduled to be done via ZOOM with the executive committee in early February. It will be made available to you following that meeting. Keep your eyes open for a follow up email. There is no cost to you for this training.
